## Personal/Directors Guarantee and Indemnity

IN CONSIDERATION of Fortifire Pty Ltd T/A Fortifire and its successors and assigns ("Fortifire") at the request of the Guarantor (as is now acknowledged) supplying and continuing to supply goods and/or services to

### I/WE (also referred to as the "Guarantor/s") UNCONDITIONALLY AND IRREVOCABLY:

- GUARANTEE** the due and punctual payment to Fortifire of all monies which are now owing to Fortifire by the Client and all further sums of money from time to time owing to Fortifire by the Client in respect of goods and services supplied or to be supplied by Fortifire to the Client or any other liability of the Client to Fortifire, and the due observance and performance by the Client of all its obligations contained or implied in any contract or agreement with Fortifire, including but not limited to the Terms & Conditions of Trade signed by the Client and annexed to this Guarantee and Indemnity. If for any reason the Client does not pay any amount owing to Fortifire the Guarantor will immediately on demand pay the relevant amount to Fortifire. In consideration of Fortifire agreeing to supply the goods and/or services to the Client, the Guarantor charges all of its right, title and interest (joint or several) in any land, realty or other assets capable of being charged, owned by the Guarantor now or in the future, to secure the performance by the Guarantor of its obligations under this Guarantee and Indemnity (including, but not limited to, the payment of any money) and the Guarantor acknowledges that this personal guarantee and indemnity constitutes a security agreement for the purposes of the Personal Property Securities Act 2009 ("PPSA") and unequivocally consents to Fortifire registering any interest so charged. Furthermore, it is agreed by both parties that where the Guarantor is acting in the capacity as a trustee for a trust, then the Guarantor agrees to charge all its right title and interest in any land realty, or other assets capable of being charged in its own capacity and in its capacity as trustee and shall be subject to the PPSA Registration as stated above. The Guarantor irrevocably appoints Fortifire and each director of Fortifire as the Guarantor's true and lawful attorney/s to perform all necessary acts to give effect to this clause including, but not limited to, signing any document on the Guarantor's behalf which Fortifire may reasonably require to:
  - register a financing statement or financing change statement in relation to a security interest on the Personal Property Securities Register;
  - register any other document required to be registered by the PPSA or any other law; or
  - correct a defect in a statement referred to in clause 1(a) or 1(b).
- HOLD HARMLESS AND INDEMNIFY** Fortifire on demand as a separate obligation against any liability (including but not limited to damages, costs, losses and legal fees calculated on a solicitor and own client basis) incurred by, or assessed against, Fortifire in connection with:
  - the supply of goods and/or services to the Client; or
  - the recovery of monies owing to Fortifire by the Client including the enforcement of this Guarantee and Indemnity, and including but not limited to Fortifire's nominees contract default fee and legal costs; or
  - monies paid by Fortifire with the Client's consent in settlement of a dispute that arises or results from a dispute between, Fortifire, the Client, and a third party or any combination thereof, over the supply of goods and/or services by Fortifire to the Client.

### I/WE FURTHER ACKNOWLEDGE AND AGREE THAT

- I/We have received, read and understood Fortifire's Terms and Conditions prior to entering into this Guarantee and Indemnity and agree to be bound by those Terms and Conditions.**
- This Guarantee and Indemnity shall constitute an unconditional and continuing Guarantee and Indemnity and accordingly shall be irrevocable and remain in full force and effect until all monies owing to Fortifire by the Client and all obligations herein have been fully paid satisfied and performed.
- No granting of credit, extension of further credit, or granting of time and no waiver, indulgence or neglect to sue on Fortifire's part (whether in respect of the Client or any one or more of any other Guarantor(s) or otherwise) and no failure by any named Guarantor to properly execute this Guarantee and Indemnity shall impair or limit the liability under this Guarantee and Indemnity of any Guarantor. Without affecting the Client's obligations to Fortifire, each Guarantor shall be a principal debtor and liable to Fortifire accordingly.

# Fortifire Pty Ltd T/A Fortifire – Terms & Conditions of Trade

<p><b>1. Definitions</b></p> <p>1.1 <b>"Client"</b> means the person/s, entities or any person acting on behalf of and with the authority of the Client requesting Fortifire to provide the Services as specified in any proposal, quotation, order, invoice, or other documentation, and:</p> <p>(a) if there is more than one Client, it is a reference to each Client jointly and severally; and</p> <p>(b) if the Client is a partnership, it shall bind each partner jointly and severally; and</p> <p>(c) if the Client is on behalf of or part of, a Trust, shall be bound in its own capacity as a trustee; and</p> <p>(d) includes the Client's executors, administrators, successors, and permitted assigns.</p> <p>1.2 <b>"Confidential Information"</b> means information of a confidential nature whether oral, written or in electronic form including, but not limited to, this Contract, either party's intellectual property, operational information, know-how, trade secrets, financial and commercial affairs, contracts, client information (including but not limited to, <b>"Personal Information"</b> such as: name, address, D.O.B., occupation, driver's license details, electronic contact (email, Facebook or Twitter details), medical insurance details or next of kin and other contact information (where applicable), previous credit applications, credit history) and pricing details.</p> <p>1.3 <b>"Contract"</b> means the terms and conditions contained herein, together with any quotation, order, invoice or other document or amendments expressed to be supplemental to this Contract.</p> <p>1.4 <b>"Cookies"</b> means small files which are stored on a user's computer. They are designed to hold a modest amount of data (including Personal Information) specific to a particular client and website and can be accessed either by the web server or the client's computer. If the Client does not wish to allow Cookies to operate in the background when using Fortifire's website, then the Client shall have the right to enable / disable the Cookies first by selecting the option to enable / disable provided on the website, prior to making enquiries via the website.</p> <p>1.5 <b>"Fortifire"</b> means Fortifire Pty Ltd (ABN 44 152 787 034) T/A Fortifire, its successors and assigns or any person acting on behalf of and with the authority of Fortifire Pty Ltd T/A Fortifire.</p> <p>1.6 <b>"Goods"</b> means all Goods or Services (including but not limited to, any consultation, manufacturing and/or installation Services etc) supplied by Fortifire to the Client at the Client's request from time to time (where the context so permits the terms 'Goods' or 'Services' shall be interchangeable for the other).</p> <p>1.7 <b>"GST"</b> means Goods and Services Tax as defined within the "A New Tax System (Goods and Services Tax) Act 1999" (Cth).</p> <p>1.8 <b>"Intended Use"</b> means any associated building product and the use thereof, for which the building product is intended to be, or is reasonably likely to be, associated with the Services.</p> <p>1.9 <b>"Non-Conforming Building Product"</b> means associated building products that are regarded as Non-Conforming for an Intended Use if, when associated with the Services:</p> <p>(a) the product is not, or will not be, safe; or</p> <p>(b) does not, or will not, comply with the relevant regulatory provisions; or</p> <p>(c) the product does not perform, or is not capable of performing, for the use to the standard it is represented to conform to by or for a person in the chain of responsibility for the product.</p> <p>1.10 <b>"Price"</b> means the Price payable (plus any GST where applicable) for the Goods as agreed between Fortifire and the Client in accordance with clause 5 below.</p> <p><b>2. Acceptance</b></p> <p>2.1 The Client is taken to have exclusively accepted and it is immediately bound, jointly and severally, by these terms and conditions if the Client places an order for or accepts Delivery of the Goods.</p> <p>2.2 In the event of any inconsistency between the terms and conditions of this Contract and any other prior document or schedule that the parties have entered into, the terms of this Contract shall prevail.</p> <p>2.3 Any amendment to the terms and conditions contained in this Contract may only be amended in writing by the consent of both parties.</p> <p>2.4 The Client acknowledges that the supply of Goods on credit shall not take effect until the Client has completed a credit application with Fortifire and it has been approved with a credit limit established for the account.</p> <p>2.5 In the event that the supply of Goods requested exceeds the Client's credit limit and/or the account exceeds the payment terms, Fortifire reserves the right to refuse Delivery.</p> <p>2.6 Any advice, recommendation, information, assistance or service provided by Fortifire in relation to Goods or Services supplied is given in good faith to the Client, or the Client's agent and is based on Fortifire's own knowledge and experience and shall be accepted without liability on the part of Fortifire. Where such advice or recommendations are not acted upon then Fortifire shall require the Client or their agent to authorise commencement of the Services in writing. Fortifire shall not be liable in any way whatsoever for any damages or losses that occur after any subsequent commencement of the Services.</p> <p>2.7 Unless otherwise agreed to, the Services shall be performed during Fortifire's standard office hours of Monday – Friday 7:00am-4:30pm excluding Public Holidays.</p> <p>2.8 In the event that Fortifire is required to provide the Services urgently, that may require Fortifire's staff to work outside normal business hours (including but not limited to working, through lunch breaks, weekends and/or Public Holidays) then Fortifire reserves the right to charge the Client additional labour costs (penalty rates will apply), unless otherwise agreed between Fortifire and the Client.</p> <p>2.9 Electronic signatures shall be deemed to be accepted by either party providing that the parties have complied with Section 14 of the Electronic (Queensland) Transactions Act 2001 or any other applicable provisions of that Act or any Regulations referred to in that Act.</p> <p><b>3. Errors and Omissions</b></p> <p>3.1 The Client acknowledges and accepts that Fortifire shall, without prejudice, accept no liability in respect of any alleged or actual error(s) and/or omission(s):</p> <p>(a) resulting from an inadvertent mistake made by Fortifire in the formation and/or administration of this Contract; and/or</p> <p>(b) contained or limited from any literature (hard copy and/or electronic) supplied by Fortifire in respect of the Services.</p> <p>3.2 In the event such an error and/or omission occurs in accordance with clause 3.1, and is not attributable to the negligence and/or willful misconduct of Fortifire; the Client shall not be entitled to treat this Contract as repudiated nor render it invalid.</p> <p>3.3 In circumstances where the Client is required to place an order for Goods, in writing, or otherwise as permitted by these terms and conditions, the Client is responsible for supplying correct order information such as, without limitation, measurements and quantity, when placing an order for Goods (whether they are made to order Goods or not), ("Client Error"). The Client must pay for all Goods it orders from Fortifire notwithstanding that such Goods suffer from a Client Error and notwithstanding that the Client has not taken or refuses to take delivery of such Goods. Fortifire is entitled to, at its absolute discretion to waive its right under this sub-clause in relation to Client Errors.</p> <p><b>4. Change in Control</b></p> <p>4.1 The Client shall give Fortifire not less than fourteen (14) days prior written notice of any proposed change of ownership of the Client and/or any other change in the Client's details (including but not limited to, changes in the Client's name, address, contact phone or fax number/s, change of trustees, or business practice). The Client shall be liable for any loss incurred by Fortifire as a result of the Client's failure to comply with this clause.</p> <p><b>5. Price and Payment</b></p> <p>5.1 At Fortifire's sole discretion, the Price shall be either:</p> <p>(a) as indicated on any invoice provided by Fortifire to the Client; or</p> <p>(b) the Price as at the date of Delivery of the Goods according to Fortifire's current Price list; or</p> <p>(c) Fortifire's quoted price (subject to clause 5.2) which will be valid for the period stated in the quotation or otherwise for a period of thirty (30) days.</p> <p>5.2 Fortifire reserves the right to change the Price:</p> <p>(a) if a variation to the Goods which are to be supplied is requested; or</p> <p>(b) if a variation to the Services originally scheduled (including any applicable plans or specifications) is requested; or</p> <p>(c) where additional Services are required due to the discovery of hidden or unidentifiable difficulties (including, but not limited to, limitations to accessing the site, prerequisite work by any third party not being completed, delays in obtaining industry occupational licensing, safety considerations (including but not limited to, the discovery of asbestos), the failure of isolating valves requiring alternative means of isolation of water supplies, hard rock barriers below the surface, iron reinforcing rods in concrete, or hidden pipes and wiring/cabling etc.) which are only discovered on commencement of the Services; or</p> <p>(d) in the event of increases to Fortifire in the cost of labour or materials which are beyond Fortifire's control.</p> <p>5.3 Variations will be charged for on the basis of Fortifire's quotation, and will be detailed in writing, and shown as variations on Fortifire's invoice. The Client shall be required to respond to any variation submitted by Fortifire within ten (10) working days. Failure to do so will entitle Fortifire to add the cost of the variation to</p>	<p>the Price. Payment for all variations must be made in full at the time of their completion.</p> <p>5.4 At Fortifire's sole discretion, a non-refundable deposit may be required prior to the commencement of the Services.</p> <p>5.5 Time for payment for the Goods being of the essence, the Price will be payable by the Client on the date/s determined by Fortifire, which may be:</p> <p>(a) on or before Delivery of the Goods;</p> <p>(b) on completion of the Services;</p> <p>(c) by way of progress payments in accordance with Fortifire's specified progress payment schedule. Such progress payment claims may include the reasonable value of authorised variations and the value of any Goods delivered to the site but not yet installed;</p> <p>(d) the date which is fourteen (14) days following the date of any invoice given to the Client by Fortifire; or</p> <p>(e) failing any notice to the contrary, the date which is seven (7) days following the date of any invoice given to the Client by Fortifire.</p> <p>5.6 Payment may be made by cash, electronic/on-line banking, credit card (a surcharge may apply per transaction), or by any other method as agreed to between the Client and Fortifire.</p> <p>5.7 Fortifire may in its discretion allocate any payment received from the Client towards any invoice that Fortifire determines and may do so at the time of receipt or at any time afterwards. On any default by the Client Fortifire may re-allocate any payments previously received and allocated. In the absence of any payment allocated by Fortifire, payment will be deemed to be allocated in such manner as preserves the maximum value of Fortifire's Purchase Money Security Interest (as defined in the PPSA) in the Goods.</p> <p>5.8 The Client shall not be entitled to set off against, or deduct from the Price, any sums owed or claimed to be owed to the Client by Fortifire nor to withhold payment of any invoice because part of that invoice is in dispute. Once in receipt of an invoice for payment, if any part of the invoice is in dispute, then the Client must notify Fortifire in writing within three (3) business days, the invoice shall remain due and payable for the full amount, until such time as Fortifire investigates the dispute claim, no credit shall be passed for refund until the review is completed. Failure to make payment may result in Fortifire placing the Client's account into default and subject to default interest in accordance with clause 17.1.</p> <p>5.9 Unless otherwise stated the Price does not include GST. In addition to the Price, the Client must pay to Fortifire an amount equal to any GST Fortifire must pay for any supply by Fortifire under this or any other agreement for the sale of the Goods. The Client must pay GST, without deduction or set-off of any other amounts, at the same time and on the same basis as the Client pays the Price. In addition, the Client must pay any other taxes and duties that may be applicable in addition to the Price except where they are expressly included in the Price.</p> <p><b>6. Provision of the Services</b></p> <p>6.1 Subject to clause 6.2 it is Fortifire's responsibility to ensure that the Services start as soon as it is reasonably possible.</p> <p>6.2 The Services' commencement date will be put back and/or the completion date extended by whatever time is reasonable in the event that Fortifire claims an extension of time (by giving the Client written notice) where completion is delayed by an event beyond Fortifire's control, including but not limited to any failure by the Client to:</p> <p>(a) make a selection; or</p> <p>(b) have the site ready for the Services; or</p> <p>(c) notify Fortifire that the site is ready;</p> <p>6.3 Delivery ("Delivery") of the Goods is taken to occur at the time that:</p> <p>(a) the Client or the Client's nominated carrier takes possession of the Goods at Fortifire's address; or</p> <p>(b) Fortifire (or Fortifire's nominated carrier) delivers the Goods to the Client's nominated address even if the Client is not present at the address.</p> <p>6.4 At Fortifire's sole discretion, the cost of Delivery is in addition to the Price.</p> <p>6.5 Fortifire may deliver the Goods/Services in separate instalments. Each separate instalment shall be invoiced and paid in accordance with the provisions in these terms and conditions.</p> <p>6.6 The Client must take Delivery by receipt or collection of the Goods whenever they are tendered for Delivery.</p> <p>6.7 Any time specified by Fortifire for Delivery of the Goods/Services is an estimate only and Fortifire will not be liable for any loss or damage incurred by the Client because of Delivery being late. However, both parties agree that they shall make every endeavour to enable the Goods/Services to be delivered at the time and place as was arranged between both parties. If Fortifire is unable to supply the Goods/Services as agreed solely due to any action or inaction of the Client, then Fortifire shall be entitled to charge a reasonable fee for redelivery and/or storage of the Goods.</p> <p><b>7. Risk</b></p> <p>7.1 Risk of damage to or loss of the Goods passes to the Client on Delivery and the Client must insure the Goods on or before Delivery.</p> <p>7.2 If any of the Goods are damaged or destroyed following Delivery but prior to ownership passing to the Client, Fortifire is entitled to receive all insurance proceeds payable for the Goods. The production of these terms and conditions by Fortifire is sufficient evidence of Fortifire's rights to receive the insurance proceeds without the need for any person dealing with Fortifire to make further enquiries.</p> <p>7.3 If the Client requests Fortifire to leave Goods outside Fortifire's premises for collection or to deliver the Goods to an unattended location, then such Goods shall be left at the Client's sole risk.</p> <p>7.4 Fortifire, at its sole discretion, may choose to maintain a contract works insurance policy until the Services are completed. Upon completion of the Services all risk for the Services shall immediately pass to the Client.</p> <p>7.5 Fortifire shall be entitled to rely on the accuracy of any plans, design specifications (including, but not limited to, existing structural and architectural drawings, fit-out architectural background and fire services consultant drawings etc) and other information provided by the Client. The Client acknowledges and agrees that in the event that any of this information provided by the Client is inaccurate, Fortifire accepts no responsibility for any loss, damages, or costs however resulting from these inaccurate plans, specifications or other information.</p> <p>7.6 The Client warrants that any structures to which the Goods are to be affixed are able to withstand the installation of the Goods and that any electrical connections (including, but not limited to, meter boxes, main switches, circuit breakers, and electrical cable) are of suitable capacity to handle the Goods once installed.
